WHEREAS, State law requires that Recorder duties and responsibilities be absorbed by the County Clerk in instances where the electorate abolish a separate Office of the Recorder, and

WHEREAS, the County Board desires to present the following question to the electorate, via a referendum on the April 5, 2011, countywide ballot:

**"Shall the County Recorder of Deeds Office be abolished and its responsibilities assumed by the County Clerk's Office?"**
