

You agree to accept as the true and accurate copy of this Agreement the version hereof maintained with respect to the date of the applicable Customer Order or Registration by MSDSonline in the course of its normal backup and archival process.

12.2 <u>Entire Agreement</u>. The Parties hereby irrevocably submit and consent to the personal and subject matter jurisdiction of such courts and irrevocably waive any objection or claim that venue is improper for any reason in such courts.

12.5 <u>Arbitration</u>. Except for any claims or actions seeking injunctive relief for a breach or alleged breach of Section 5 or Section 6, any dispute, claim, or controversy arising out of, or relating to, this Agreement (a "Dispute") shall be addressed in accordance with this Section 12.5. Each Party agrees to notify the other in writing as soon as reasonably practicable after becoming aware of the basis of a Dispute and to use commercially reasonable efforts to informally resolve or settle the Dispute after providing or receiving such a notice. Notwithstanding the foregoing, where the dispute is monetary in nature and the amount involved does not exceed \$30,000.00, either party may waive arbitration and prosecute the claim in a court having jurisdiction consistent with Section 12.4 above.

12.6 <u>Attorneys' Fees</u>. In any arbitration, suit, action, or proceeding relating to this Agreement, the prevailing Party will have the right to recover from the other its costs and reasonable fees and expenses of attorneys, accountants, and other professionals incurred in connection therewith. MSDSonline shall also be entitled to reimbursement for any and all of its collection costs in the event of late payment or nonpayment by Customer.

12.7 <u>Severability</u>. Every provision of this Agreement shall be construed, to the extent possible, so as to be valid and enforceable. The waiver of any default by either Party shall not be deemed a continuing waiver, but shall apply solely to the instance to which such waiver is directed.

12.10 <u>Assignment; Change in Control</u>. All rights granted to Customer herein are personal to Customer and Customer may not assign, delegate, or otherwise transfer this Agreement or any of Customer's rights or obligations hereunder, either voluntarily or by operation of law, without the prior written consent of MSDSonline, which consent shall be in MSDSonline's sole discretion. MSDSonline may assign this agreement without consent to (i) a parent or subsidiary, (ii) an acquirer of assets, or (iii) a successor by merger. 

## **RELEASE AND SETTLEMENT AGREEMENT**

Whereas, this Release and Settlement Agreement ("Agreement") is entered into this <u>4</u>^{+h} day of <u>Mag</u>, 2016, by and between **County** SHERIFF'S ("Plaintiff"), and ROBERT M. HUSTON, TAZEWELL COUNTY SHERIFF'S OFFICE, UNIDENTIFIED TAZEWELL COUNTY SHERIFF EMPLOYEES, AND TAZEWELL COUNTY (collectively referred to as the "Parties").


Whereas, Plaintiff filed a state law action in the Tenth Judicial Circuit of Illinois, Tazewell County, Illinois, Docket Number (1997) (the "Action"), pursuant to the laws of the State of Illinois, against ROBERT M. HUSTON, TAZEWELL COUNTY SHERIFF'S OFFICE, UNIDENTIFIED TAZEWELL COUNTY SHERIFF EMPLOYEES, AND TAZEWELL COUNTY (collectively "Defendants").

Whereas, the Parties, having had the advice of their respective counsel, have determined that it is in their individual and mutual best interests to settle and compromise Plaintiff's claim or claims that could have been brought, on the terms and conditions recited herein this Agreement, without any admission of fault, liability or wrongdoing on behalf of Defendants.

WHEREFORE, in consideration of the promises and covenants contained herein this Agreement, the Parties agree as follows:

RELEASE OF CLAIMS: Plaintiff, being an adult and otherwise 1. competent to execute this document, agrees for the sole consideration of payment of TWENTY FIVE THOUSAND DOLLARS AND NO CENTS U.S.D. (\$25,000.00 U.S.D.), receipt which will be made within a reasonable time after execution of this Agreement, but no more than thirty (30) days after execution of this Agreement and the dismissal with prejudice of the Action against Defendants, does hereby release, acquit, and forever discharge Robert M. Huston, Tazewell County Sheriff's Office, any Tazewell County Sheriff's Office Employees, Tazewell County and any of their employees or former employees, agents or former agents, officers or former officers, and their insurers and claims administrators, including the Illinois Counties Risk Management Trust ("ICRMT") and Illinois Program Managers Group ("IPMG"), their agents, servants, employees, successors, heirs, officers, directors, and privies (collectively, the "Release" Parties"), from any and all claims, actions, causes of action, demands, rights, damages, costs, loss of services, expenses and compensation, on account of or in any way growing out of any and all injuries, known or unknown, present or which may be discovered at a future date, arising out of the alleged April 13, 2015 dissemination of Plaintiff's mug shot and the alleged injury Plaintiff sustained while eating food during his incarceration in Tazewell County in 2015 (the "Incident"), as more fully described in Plaintiff's Complaint filed in the Action.

It is further understood and agreed that this settlement is the compromise of a doubtful and disputed claim, and that this settlement and the payment made pursuant thereto are not to be construed as an admission of liability on the part of the Release



Parties, Defendants, or any Party hereinabove referenced to be released, and that the Release Parties and Defendants deny any and all liability with respect to the aforesaid described Incident or any allegations or events described in the Complaint or the Action and intend merely to avoid the cost of further litigation in this matter.

Plaintiff fully understands that any injuries or damages sustained by him as a result of the aforesaid Incident are or may be permanent and progressive in nature and that recovery therefrom may be uncertain and that there may be unknown or undetermined injuries, losses, medical expenses, and other expenses or damages resulting from the aforesaid Incident, and that in executing this Agreement it is understood and agreed that this Release is a final release and is intended to include all such undetermined or future injuries, losses, medical expenses, and other expenses or damages.

Plaintiff further understands and agrees that this Agreement and his receipt of the consideration in Paragraph 1, is conditioned upon the Court in this Action entering an Order finding that this Agreement and the settlement described in herein is made in good faith pursuant to the Joint Tortfeasors Contribution Act, 740 ILCS 10/.01, et. seq.. and that the consideration described in Paragraph 1 will be made within a reasonable time the entry of said Order.

2. ATTORNEYS' FEES AND COSTS: The payment herein made to Plaintiff, pursuant to this Release and Settlement Agreement, is in full and final settlement and satisfaction of all claims, expressly including any and all of Plaintiff's attorneys' fees and costs associated with this litigation. This payment fully satisfies any obligation or lien Defendants, the Release Parties, or the Parties previously identified have or may have to Powers Law, P.C. or Ryan L. Powers, or any attorney employed by or associated with said law firm, or that may have previously represented Plaintiff in connection with this Action, for attorneys' fees and costs. The Parties agree that each Party shall bear their respective costs in bringing or defending this Action, including any costs associated with experts and attorneys.

3. **INDEMNITY AND HOLD HARMLESS:** Plaintiff agrees to indemnify and hold harmless Defendants, the Release Parties, and the Parties previously identified in this Agreement from any and all costs, fees, hospital or healthcare liens, subrogation or reimbursement liens associated with any hospital or medical care and treatment, bills, expenses, liabilities, and losses, which have been or might be incurred as a result of any past or future medical care and treatment arising out of this Incident as fully described herein this Agreement.

Further, Plaintiff agrees that he shall be solely responsible for, and promises and agrees to pay, any income or other taxes, interest or penalties owed with respect to the payments referred to in this Agreement, and will indemnify and hold harmless Defendants and the Release Parties from and against any interest, penalties or taxes as a result of Plaintiff's failure to report and pay any taxes due on any of the payments.

Further, the Parties agree that all sums paid pursuant to this Agreement constitute damages on account of personal or physical injuries or physical sickness within the meaning of Section 104(a)(2) of the Internal Revenue code of 1986 (26 U.S.C.) and Canadian law including IT-365R2, as amended, arising from any physical injuries that resulted from the claims and allegations made in the litigation. No portion of the proceeds paid under this Agreement represent exemplary or punitive damages.

4. NO ADMISSION OF LIABILITY: Plaintiff understands and agrees that the settlement of this claim and all payments made pursuant thereto are made for the sole purpose of settlement and compromise only, to avoid the cost and expense, uncertainty and time associated with further litigation, and without any admission by the Release Parties or Defendants as to fault, liability, or wrongdoing, all of which are expressly denied.


Further, this Agreement is not and shall not be construed as evidence of, or an admission by, any Party hereto that any claim or fact alleged by the other party to this litigation is true or correct. Neither this Agreement nor any of its terms shall be offered or received in evidence in any other action or proceeding or utilized in any manner whatsoever by Plaintiff or any third party as an admission or concession of liability or wrongdoing on behalf of the Defendants or the Release Parties.

CONFIDENTIALITY: Plaintiff agrees to keep the fact and terms of this Agreement strictly confidential, other than to state that the matter has been resolved, and Plaintiff shall not directly or indirectly disclose, divulge or reveal any of the terms and conditions of this Agreement to any person, entity, or any print, radio, television or online news media outlet, by any means, whether orally, in writing, or by digital or electronic communication, including any social media, networking site, public forum or commentary, or any online blog, except for Plaintiff's attorneys, accountant, or other financial consultant on a privileged basis, and except for a spouse, parent, sibling, or child of the Plaintiff on a confidential basis, in which case said spouse, parent, sibling or child also shall not disclose, divulge or reveal said information.

Plaintiff further represents that he has not engaged in any conduct prior to the execution of this Agreement, which would violate the spirit and terms of this confidentiality clause, and agrees that any prior disclosure to a spouse, parent, child, attorney, accountant, or financial consultant shall be governed by the terms of this Paragraph 5. Plaintiff may discuss the facts and terms of this Release with the Internal Revenue Service or similar governmental agency where required to comport with a legal duty to so disclose said terms and conditions, or as otherwise required to by law.

In the event that any suit is brought to enforce this confidentiality clause or for breach of this Agreement, either Party may refer to this Agreement and any of its terms, provided that the Agreement is kept under seal by the Court pursuant to a protective order.

Plaintiff further understands and agrees that his right to receive and retain the



consideration described above in Paragraph 1, is conditioned upon his agreement to and compliance with these terms and the other terms of the Agreement. Plaintiff specifically agrees that in addition to, and not in lieu of, any other rights and remedies, the Release Parties and Defendants may sue for and obtain injunctive relief to enforce any breach or threatened breach of the terms of this Agreement and this Paragraph 5. The Parties hereto agree that any disclosure by Plaintiff, in violation of this Paragraph 5, will constitute a breach of this Agreement, with liquidated damages of \$50 per occurrence. Plaintiff further agrees that in any lawsuit brought by the Release Parties or Defendants to enforce or for a breach of this Agreement, that the Release Parties and/or Defendants shall be entitled to the cost of bringing that suit as well as reasonable attorneys' fees.

6. **DISMISSAL:** Plaintiff agrees to the prompt dismissal of this Action as to Defendants, with prejudice, and to take any and all actions necessary to effect said dismissal, with prejudice, including filing the appropriate Motions with the Tenth Judicial Circuit of Illinois, Tazewell County.

7. **CHOICE OF LAW:** The Parties agree that this Agreement shall be governed by and construed and interpreted according to the laws of the State of Illinois.

8. ENTIRE AGREEMENT: The Parties agree that all of the terms, conditions, covenants, promises, and warranties by and between the parties are contained herein this Agreement. All prior agreements, negotiations, representations, covenants, promises and warranties concerning this Action are merged into this Agreement. This Agreement may not be modified except by written agreement of all of the parties duly executed by all of the Parties.

Plaintiff, and the entire Agreement before affixing his signature thereto, that he had an opportunity to consult his attorney prior to the execution thereof, that he fully understands the terms and conditions of this Agreement, and is voluntarily and freely executing this Agreement in consideration of the mutual covenants and promises made therein, and that no additional promises, consideration, or payment have been promised to him for executing and signing this Agreement.
