





AN ORDINANCE AMENDING TITLE 7, CHAPTER 1, ZONING-CODE OF TAZEWELL COUNTY ON PETITION OF RAYMOND KEIL

(Zoning Board Case No. 18-15-Z)

WHEREAS, a petition has been filed with the County Clerk of Tazewell County, Illinois, By Raymond Keil for an Amendment to the Official Zoning Maps of Tazewell County to change the Zoning Classification of property from an A-1 Agriculture Preservation Zoning District to a R-1 Low Density Residential Zoning District; and

WHEREAS, a public hearing on said application designated as Zoning Board Case No. 18-15-Z as held by the Tazewell County Zoning Board of Appeals on April 3, 2018, following due publication of notice of said hearing in accordance with law, and the said Zoning Board of Appeals thereafter made a report to the County Board recommending approval; and

WHEREAS, said report to the Zoning Board of Appeals contained the following findings of fact:

- The proposed amendment shall not be detrimental to the orderly development of Tazewell
 County.
 - (POSITIVE) The subject property lies within the 1.5-mile planning boundary of the City of East Peoria and is identified as Low Density Residential on the City's Future Land Use Map. Moreover, the area surrounding the subject property contains many areas zoned R-1. Therefore, the proposed amendment will not be detrimental to Tazewell County's orderly development.
- 2. The proposed amendment shall not be detrimental to or endanger the public health, safety, morals or general welfare of Tazewell County.
 - (POSITIVE) The applicant wishes to convert the subject property for single-family residential use, potentially creating one to two dwelling sites. Based on the size of the subject property, these dwelling sites will be similar to other residential sites in the area. Should road access, well, and septic systems be installed properly and safely, the proposed rezoning should not be detrimental to or endanger the public health, safety, morals or general welfare of Tazewell County.

- 3. The request is consistent with existing uses of property within the general area of the property in question.
 - (POSITIVE) The subject property is located in a residential area, close to a busy commuter highway. Rezoning would bring the property more in line with properties to the north, east, and west. Therefore, the request is consistent with nearby uses of property.
- 4. The request is consistent with the zoning classifications of property within the general area of the property in question.
 - (POSITIVE) The surrounding area contains many properties zoned R-1 Low Density Residential. Rezoning of the subject property would make it more consistent with nearby properties. Therefore, the request is consistent with the zoning classifications of property nearby.
- 5. The suitability of the property in question for the uses permitted under the existing zoning classification.
 - (POSITIVE) The existing zoning classification, A-1 Agriculture Preservation District, would not allow for the creation of multiple residential home sites. Therefore, the requested rezoning is necessary for the property to be put to its highest and best use.
- 6. The suitability of the property in question for the uses permitted under the proposed zoning classification.
 - (POSITIVE) The applicants plan for single-family residences is suitable under the R-1 Low Density Residential Zoning Classification.
- 7. The trend of development, if any, in the general area of the property in question, including changes, if any, which may have taken place since the property in question was placed in its present zoning classification.
 - (POSITIVE) Development in the surrounding area has largely been residential home sites. Therefore, the trend of development in the surrounding area is supportive of the proposed rezoning.
- 8. The length of time the property has been vacant as zoned, considered in the context of the land development in the area surrounding the subject property.
 - (POSITIVE) The subject property is not explicitly vacant as zoned, but none of the subject property identified for rezoning is currently used for agriculture. The property's current zoning prevents it from being brought into form with the surrounding area, which is low-intensity residential development. Therefore, this standard is considered met.

- 9. The proposed map amendment is within one and one half (1 ½) miles of a municipality and consistent with an adopted Comprehensive Plan.
 - (POSITIVE) The subject property is within 1.5 miles of the City of East Peoria. The subject property and surrounding area are identified as "Low Density Residential" on the City's Future Land Use Map. Therefore, this standard is considered met.
- 10. The relative gain to the public as compared to the hardship imposed upon the individual property owner.
 - (POSITIVE) Approval of the proposed rezoning would allow for the creation of residential homes in a largely residential area, with a minimal loss of productive agriculture land. Should the rezoning be denied, residential development pressure may be pushed to a less-appropriate area. Therefore, this standard is considered met.
- 11. The proposed amendment is consistent with the goals, objectives, and policies of the Tazewell County Comprehensive Plan.
 - (POSITIVE) The proposed zoning map amendment is consistent with the following goals, objectives, and policies of the Tazewell County Comprehensive Plan:
 - o Minimize conflict between land uses.
 - Land development occurs in locations that minimize the degradation of natural resources.
 - Locate new residential development in rural areas close to roadways to preserve contiguous tracts of farmland.







PROPOSED AMENDMENTS TO TITLE 7, CHAPTER 5 TAZEWELL COUNTY BUILDING AND PROPERTY MAINTENANCE CODE

ARTICLE I. GENERAL

7TCC 5-1 (a) Scope

(1) The County of Tazewell adopts as the Building and Property Maintenance Code, the following documents with certain insertions, deletions and changes:

International Residential Building Code 2012
International Building Code 2012
International Property Maintenance Code 2012
NFPA 70: National Electrical Code 2011 Edition
State of Illinois Plumbing Code Part 890 Illinois Administrative Code
International Mechanical Code 2012
International Fire Code 2012
Illinois Accessibility Act 1996
International Illinois Energy Conservation Code 2012

7TCC 5-1 (c) Effective date.

This chapter and the codes adopted herein by reference shall be effective as of January 1, 2014. May 1, 2018.

7TCC 5-1 (h) References in codes adopted herein by reference.

(8) Any reference to the "International Energy Conservation Code" shall be read as the "Illinois Energy Conservation Code, Part 600 Illinois Administrative Code" as the code reads as of the time of this language or as the code is amended and updated.

ARTICLE 2. BUILDING CODE

7TCC 5-2 (a) Compliance with the 2012 International Building <u>Illinois Energy Conservation</u> Code required.

The 2012 International Building *Illinois Energy Conservation* Code is hereby adopted by reference.

7TCC 5-2 (b) Amendments to 2012 International Building Illinois Energy Consercation Code.

The 2012 International Building *Illinois Energy Conservation* Code as adopted herein by reference is amended as provided in this section.

(3) Section 101.4.6 "Energy" is hereby amended to read as follows:

101.4.6 Energy. The provisions of the currently adopted International Illinois Energy Conservation Code shall apply to all matters governing the design and construction of buildings for energy efficiency.

The 2012 International Illinois Energy Conservation Code is <u>as</u> hereby adopted herein by reference is amended as provided in this section. <u>Amendments in this section shall apply to both the Commercial provisions and Residential Provisions of the Illinois Energy Conservation Code.</u>

 - a. without expense to the LA, even though final payment has been received by ENGINEER, to the extent they are caused by the ENGINEER's negligent acts, errors or omissions in the performance of professional services under this AGREEMENT and those of anyone for whom the ENGINEER is legally liable; or,
 - b. at the expense of the LA to the extent they are caused by the LA's negligent acts, errors or omissions in the performance of professional services under this AGREEMENT and those of anyone for whom the LA is legally liable, and arising from the project that is the subject of this AGREEMENT.
- That basic survey notes and sketches, charts, computations and other data prepared or obtained by the Engineer
 pursuant to this AGREEMENT will be made available, upon request, to the LA without cost and without restriction
 or limitations as to their use.
- 6. To make such changes in working plans, including all necessary preliminary surveys and investigations, as may be required after the award of the construction contract and during the construction of the improvement.
- 7. That all plans and other documents furnished by the ENGINEER pursuant to this AGREEMENT will be endorsed by him and will show his professional seal where such is required by law.
- 8. To submit, upon request by the LA a list of the personnel and the equipment he/she proposes to use in fulfilling the requirements of this AGREEMENT.

The LA Agrees,

1. To pay the ENGINEER as compensation for all services performed as stipulated in paragraphs 1a, 1b, 2, 3, 4, 5 and 6 in accordance with the following method:

At the hourly rates attached hereto and considered part hereof at a total cost not-to-exceed \$230,000.00

Hourly rates to be considered as full compensation for all actual costs to ENGINEER plus profit, overhead and readiness to serve - "actual costs" being defined as material cost plus payrolls, insurance, social security, and retirement deductions plus traveling and other out-of-pocket expenses.

"Cost to Engineer" to be verified by furnishing the LA copies of invoices from the party doing the work. The classifications of the employees used in the work should be consistent with the employee classifications for the services performed. If the personnel of the firm, including the Principal Engineer, perform routine services that should normally be performed by lesser-salaried personnel, the wage rate billed for such services shall be commensurate with the work performed.

- 2. That payments due the ENGINEER for services rendered in accordance with this AGREEMENT will be made as soon as practicable after the services have been performed in accordance with the following schedule:
 - a. Upon completion of general and detailed proposals incorporating plans, special provisions, and estimates of cost to be furnished by LA being the work required by paragraphs 1a through 1b under THE ENGINEER AGREES to the satisfaction of the LA, 90 percent of the total fee due under this AGREEMENT based on the approved estimate of cost.

- b. Upon award of the contract for the improvement by the LA,100 percent of the total fee due under this AGREEMENT based on the awarded contract cost, less any amounts paid under "a" above.
- By Mutual agreement, partial payments, not to exceed 90 percent of the amount earned, may be made from time to time as the work progresses.
- 3. That, should the improvement be abandoned at any time after the ENGINEER has performed any part of the services provided for in paragraphs 1a through 1b and prior to the completion of such services, the LA shall reimburse the ENGINEER for his work completed through the date of such abandonment at the hourly rates established and up to the total cost not-to-exceed amount in accordance with paragraph 1 of THE LA AGREES.
- 4. That, should the LA require changes in any of the detailed plans, specifications or estimates, except for those required pursuant to paragraph 4 of THE ENGINEER AGREEs, after they have been approved by the LA, the LA will pay the ENGINEER for his work to complete such changes at the hourly rates in accordance with paragraph 1 of THE LA AGREES. It is understood that "changes" as used in this paragraph shall in no way relieve the ENGINEER of his responsibility to prepare a complete and adequate set of plans and specifications.
- 5. That all plans and other documents furnished by the LA pursuant to this AGREEMENT will be endorsed and will show a professional seal where such is required by law.

It is Mutually Agreed,

- 1. That any difference between the ENGINEER and the LA concerning their interpretation of the provisions of this AGREEMENT shall be referred to a committee of disinterested parties consisting of one member appointed by the ENGINEER, one member appointed by the LA and a third member appointed by the two other members for disposition and that the committee's decision shall be final.
- 2. This AGREEMENT may be terminated by the LA upon giving notice in writing to the ENGINEER at his last known post office address. Upon such termination, the ENGINEER shall cause to be delivered to the LA all surveys, permits, agreements, preliminary bridge design & hydraulic report, drawings, specifications, partial and completed estimates and data, if any from traffic studies and soil survey and subsurface investigations with the understanding that all such material becomes the property of the LA. The ENGINEER shall be paid for any services completed and any services partially completed in accordance with Section 4 of THE LA AGREES.
- 3. That if the contract for construction has not been awarded one year after the acceptance of the proposal by the LA, the LA will pay the ENGINEER the balance of the engineering fee due to make 100 percent of the total fees due under this AGREEMENT, based on the estimate of cost as prepared by the ENGINEER and accepted by the LA.
- 4. ENGINEER agrees to indemnify LA for costs, losses, and damages to the extent they are caused by the ENGINEER's negligent acts, errors or omissions in the performance of professional services under this Agreement and those of anyone for whom the ENGINEER is legally liable.
- 5. LA agrees to indemnify the ENGINEER for costs, losses, and damages to the extent they are caused by the LA's negligent acts, errors or omissions in the performance of professional services under this AGREEMENT and those of anyone for whom the LA is legally liable, and arising from the project that is the subject of this AGREEMENT.
- 6. That the ENGINEER warrants that he/she has not employed or retained any company or person, other than a bona fide employee working solely for the ENGINEER, to solicit or secure this contract, and that he/she has not paid or agreed to pay any company or person, other than a bona fide employee working solely for the ENGINEER, any fee, commission, percentage, brokerage fee, gifts or any other consideration, contingent upon or resulting from the award or making of this contract. For Breach or violation of this warranty the LA shall have the right to annul this contract without liability.
