The following items were removed from the Consent Agenda for further discussion.

**Item 1 Land Use:** Member Imig made a motion to approve an ordinance amending the Official Zoning Maps of Title XV, Chapter 157 of the Tazewell County Zoning Board of Appeals – Case No. 20-20-Z; seconded by Member Hovey. Motion to approve the amendment was passed by voice vote of 19 Yeas; 0 Nays.

**Item 12 Executive:** Member Sinn stated he would vote no on the resolution, voicing concerns with the merger of the Tri-County Regional Planning Commission and Peoria-Pekin Urbanized Area Transportation Study (PPUATS). He was concerned about the representation of IDOT and CityLink voting on regional issues, and how this could affect Tazewell County.

Member Crawford stated ten members were on Executive Committee, including Member Menold and himself representing Tazewell County. He spoke on the creation of the Bylaws of the newly merged commission, which included a ten year automatic review. He encouraged support for this resolution, because failure to support could jeopardize the success and cost Tazewell County millions of dollars.

Member Graff voiced concern that the previous commission had not been reviewed for over sixty years, and he spent valuable time researching review language to guarantee the merged commission had a review option. He voiced disappointment that the ten year automatic review placed in the bylaws was not communicated to board members prior to the meeting.

Member Menold explained that the merger would be more efficient and was the right thing for Tazewell Count, y and he planned on supporting resolution.

Member Atkins explained that he was in agreement with Member Crawford regarding the bylaws and he felt that Tazewell County would benefit from this merger. He stated he did understand Member Sinn's concerns.

Member Hovey stated he echoed all the sentiments mentioned at the meeting and he was in strong support of this merger. He voiced appreciation to both organizations and stated he always encountered good things with both groups. He stated the focus of the merged commission needs to be region based, not a rural or urban focus.

Member Minton acknowledged that the recent Tazewell County Executive Committee had a lengthy discussion regarding this merger. She stated she agreed with Member Graff and would like to see a five year review rather than a ten year review.

Member Crawford spoke on the cost savings this merger would bring to Tazewell County.

Member Sinn voiced concern with specific money being used for non-transportation needs.

Member Hovey made a motion to approve resolution for Amendment to the Establishment of Tri-County Regional Planning Commission; seconded by Member Crawford. Motion to approve the Amendment to the Establishment of a Tri-County Regional Planning Commission was passed by voice vote of 16 Yeas; 3 Nays Minton, Sinn & Imig.
