**PUBLIC HEARING ON APPORTIONMENT PLAN**

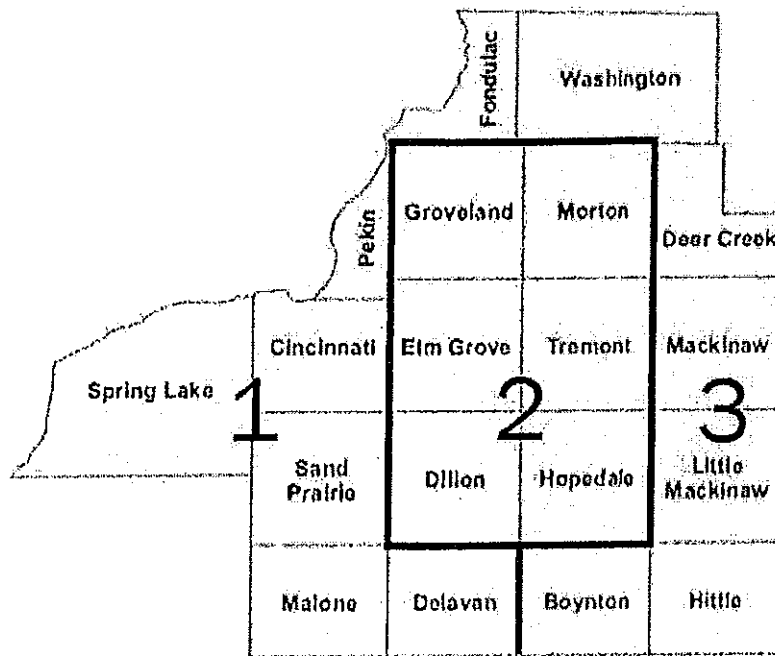
