- 2) Your application must be signed by you.
- 3) Submit a copy of your identification (see below for acceptable forms of identification).
- 4) Include your payment (see below for acceptable forms of payment).

FEES:

- -One record search including one certified copy is \$15.00.
- -Each additional certified copy of the same record issued at the same time is \$11.00.
- -Uncertified copy of record that is 20 years or older marked "For Genealogical Purposes Only" is \$5.00.
- -There is an additional convenience fee for online purchases, see website.

Methods of Payment: Cash, check or credit/debit card
